Overview

The UN Global Compact is the world's largest corporate sustainability initiative. It provides a universal language for corporate responsibility and provides a framework to guide all businesses.

In Australia, the business-led Global Compact Network Australia brings together signatories to the UN Global Compact, including a number of Australia's leading companies, non-profits and universities, to advance corporate sustainability and the private sector's contribution to sustainable development.

The Board

The Board provides leadership and Governance for the GCNA. The main functions of the Board are to:

- Ensure effective leadership of the organisation;
- Promote and ensure effective performance of the organisation;
- Set and assess the objectives and standards of the organisation;
- Monitor the financial, legal, ethical and regulatory performance of the organisation; and
- Provide links to the UN Global Compact.

The Board is currently comprised of seven directors, who serve for a term of two years. The total number of directors allowed under the GCNA's Constitution is ten.

We seek the appointment of candidates to assist in contributing to our capability and diversity gaps. The appointments allow candidates the opportunity to join a dynamic Board working to capitalise on opportunities while assisting with raising the profile of the GCNA.

Key attributes:

In line with the role of the board outlined above, the key attributes we are seeking in a Board candidate are:

- Demonstrated skills at in one of the following areas:
 - o Legal / corporate governance;
 - o Compliance and risk management;
 - o Strategic communications, particularly media relations;
 - o Executive leadership;
 - o Financial management; or
 - o Government relations.
