

Global Compact Network Australia: 2021 Membership Benefits – Parent Organisations

Business signatories to the UN Global Compact can choose between two tiers of engagement: [Signatory or Participant](#). The financial contribution is based on the tier chosen and the business' annual revenue.

- For businesses with an annual revenue over US\$50m (Corporate) and participant-tier businesses with annual revenue less than US\$50m (SME) the financial contribution to join the UN Global Compact **includes** GCNA membership.
- For signatory-tier businesses with an annual review less than US\$50m (SME) and non-business organisations there is a voluntary financial contribution to join the UN Global Compact. A financial contribution is, however, payable to join the GCNA.

Financial contributions will be invoiced by the GCNA in Australian dollars. For all corporate and SME participant-tier members, the GCNA receives 45% of the above financial contributions. GST is applicable only to the Australian component of the fee. For all SME signatory-tier members, subsidiary members and non-business organisations, the GCNA receives 100% of the contributions.

The exchange rate is based on the three-month rolling average to 1 October 2020 (USD:AUD 1.39).
